o ***Each shipment shall be accompanied by an ORIGINAL signed document from the producer/manufacturer confirming that: 1) all samples are of bovine and/or ovine origin, 2) samples shipped from countries considered by the USDA to be FREE of FMD are identified by the country of origin, 3) samples from FMD affected countries will undergo one of the following treatments prior to importation: heat treatment at a minimum of 72°C for a minimum of 30 minutes; OR a pH of 5.5 or less for a minimum of 30 minutes; OR a pH of 10 or greater for a minimum of 2 hours; OR immersion in a minimum of 0.4% beta propriolactone/12 hours/4°C/pH 7; OR immersion in a minimum of 0.2% glutaraldehyde; OR immersion in a minimum of 10% formalin; OR treatment with proteinase K, followed by a heat treatment at 95°C for 15 minutes, followed by RNase; OR FTA paper; OR affinity chromatography, and 4) the exported material was not exposed to or commingled with any other animal origin material.
